# IMPORTANT INFORMATION REGARDING THE FELLOWSHIP.

A key goal of the fellowship program is to empower a diverse group of aspiring leaders with the critical skills and knowledge needed to enact ethical, equitable and inclusive policies and practices. Fellowships are up to \$5K and those receiving fellowships will be known as Lincoln Institute Fellows for Ethics and Equity.

### **FELLOWSHIP TERMS**

- Fellows must have completed a baccalaureate degree from a recognized US institution or ministry of education.
- Fellowship funds will be disbursed in installments each term not to exceed 50% of the student's term tuition.
- Fellowship funds have no cash value and are only applied toward tuition charges.
- Fellows must remain in good academic and financial standing or fellowship will be forfeited.
- A fellowship award does not guarantee admission to Claremont Lincoln University. If selected, fellows will be guided through CLU's admissions process for the MPA, which requires an online application, and a copy of your unofficial undergraduate transcript. We do not require a GRE or GMAT for acceptance. CLU's acceptance decisions are typically provided within 24 hours once an application has been submitted.

### **APPLICATION REVIEW**

Candidates will be independently reviewed by five panelists, including  
2 reviewers from the Lincoln Institute,  
2 reviewers from CLU's MPA Inaugural Advisory Council, and  
1 reviewer from CLU MPA department.
